Jeff Shorba, State Court Administrator, presented an overview of the FY 20-21 judicial branch budget proposal.

Determine Recommendations

James Wenzler moved to recommend the District Court Judges receive a salary increase of 4% in FY 21 and FY 22 and that Appeals Court Judges and Supreme Court Justices receive a salary increase of 2% in FY 21 and FY 22. Seconded.

James Robbins moved to amend the Wenzler motion to recommend that District Court Judges receive a salary increase of 3.75% in FY 21 and FY 22 and the Appeals Court Judges and Supreme Court Justices

receive a salary increase of 3.5% in FY 21 and FY 22. Seconded.

James Wenzler moved to authorize the Chair to submit the 2019 Compensation Council report on behalf of the Council. THE MOTION PREVAILED.
